**CHARGES FOR TESTING OF TEA SAMPLES AT THE ANALYTICAL
LABORATORY OF THE SRI LANKA TEA BOARD**

This refers the section III of our Circular No. OR/1/87 dated 06th August 2010 addressed to all registered Exporters of Tea, Importers of Tea, Packers of Tea and Warehouse Owners of Tea under the caption 'Levy of Fees & Charges for Board's Services'.

02. It is observed that tea sample/s forwarded to the Laboratory for analysis, by most of the customers are adopted their own methods and therefore the Analytical Laboratory not in a position to carryout required analysis and issue test certificates due to lack of information. In order to streamline the procedure for submitting the sample/s for obtaining required test certificate/s from the Analytical Laboratory of the Sri Lanka Tea Board, the following procedural steps are introduced with applicable charges for each test.

The chargers for each test are appended below;



02. In order to carry out those tests you are required to forward;
- I. Tea sample/s each 100grm net weight in a sealed container with consumer pack bearing all identification mark/s and number/s.
 - II. In case of microbiological analysis of tea, it is compulsory to use sterilized utensils for sampling from the teas stored.
 - III. Duly completed application form annexed hereto (Form AL/T)
 - IV. Letter of request describing the test requirements with documentary evidence in support of the request for each certificate.
 - V. Payment for test/s either by cheque drawn in favour of the "Sri Lanka Tea Board" or by cash to the Finance Division of Sri Lanka Tea Board.
 - VI. Prior to make the payment it is necessary to obtain authorization from the Assistant Director (Laboratory).
