(If You are wish to register for 05 sub categories like 1a, 1b, 1c, 1d, 1e you have to pay Rs. 2500/-). Payment can be made by Cash or Cheques to the Finance Division of Sri Lanka Tea Board. Cheques should be drawn in favour of Sri Lanka Tea Board.

Application should be made on the prescribed set of forms obtainable from the web site or folowing office. Prospective applicants are required to produce a letter of request on a letterhead mentioning the service and the number of the category with the filled application form, according to this Paper Advertisement. Application forms can be downloaded, free of charge.

Applications should be forwarded under registered post or hand delivered to cover marked as "Registration of Suppliers/Contractors - 2025" on the top left-hand corner of the envelop to reach the Director General, Sri Lanka Tea Board, 574, Galle Rd, Colombo 3 on or before 3:00 p.m. on 29th November 2024.

- Quotations for supply of items/providing services will normally be invited from the list of Registered Suppliers. However the SLTB reserves the right to invite quotations and purchases from any other source or register new suppliers as an when necessary.
- If registration is sought for more than one main category, a separate application should be submitted for each main category.
- Only eligible suppliers will be selected. 5.
- Registrtion for motor vehicle repair and service providers will be done only after detailed Assessment including physical 6. verification and site visit by the Tea Board.
