## SUBSIDY SCHEME FOR THE PURCHASE OF TEA DRYERS FOR ARTISANAL TEA FACTORIES - 2025

#### 1.0 Introduction:

Having considered the request of the stakeholders of the tea industry who are involved in the manufacture of artisanal teas, Sri Lanka Tea Board has decided to grant a subsidy amounting to 50% of the cost of a tea dryer not exceeding Rs. 200,000 per unit to embark on a proper manufacturing process.

## 2.0 Scope of the subsidy scheme for the purchase of tea dryers for artisanal tea factories:

- (i) The subsidy will be paid only for the purchase and establishment of a tea dryer in the factory.
- (ii) The purchase of a tea dryer should be in accordance with the specifications given by the Tea Research Institute of Sri Lanka.
- (iii) Subsidies will be paid on a "First Come First Serve" basis due to limited available funds.

#### 3.0 Method of application:

- (i) Application for the scheme should be made in the prescribed application form No. TB/TC/ATM/2025
- (ii) Only the registered manufacturer is authorized to sign the application.
- (iii) Duly completed application forms together with originals of Performa invoices should be forwarded to the Assistant Tea Commissioner of the area on or before 15st February 2025.

## 4.0 Eligibility for funding under the subsidy scheme:

- (i) Only brand-new tea dryers purchased within a given period is eligible for subsidy assistance.
- (ii) Only Artisanal tea manufacturers that perform in accordance with sections 8 (2) and 11(a) of the Tea Control Act No. 51 of 1957 to the satisfaction of the Tea Commissioner will be eligible to receive subsidy funds.

#### 5.0 Method of payment of subsidy:

- (i) Approval for the purchase tea dryer must be obtained from the Tea Commissioner. The tea dryer purchased prior to the approval of the SLTB will be disqualified from receiving subsidy assistance.
- (ii) Once the application is received, necessary inspections will be carried out to ascertain the necessity of the tea dryer for the factory.
- (iii) The approval will be conveyed to the applicant and he/she may have to complete the installation.
- (iv) Once the installation of the tea dryer is completed and its use in the tea manufacture of artisanal tea has commenced, the applicant should inform the Assistant Tea Commissioner for inspection.
- (v) Approval should be obtained from the Tea Commissioner for any deviation for items (i) to (iv) above.
- (vi) The subsidy payment will directly be made to the bank account number of beneficiary. The beneficiary should provide the bank details with the application.

#### 6.0 Disposal of items machinery and equipment:

A dryer installed under this subsidy assistance should not be disposed of or removed from the tea factory before five (05) years of the date of installation without written approval from the Tea Commissioner. If any dryer or parts of it is disposed of or removed from the tea factory without written approval from the Tea Commissioner before five (05) years of installation the total amount of subsidies shall be paid back to the Sri Lanka Tea Board by the registered manufacturer of tea.
