SRI LANKA TEA BOARD (WAREHOUSING OF TEA) REGULATIONS -1984
REGISTRATION / RENEWAL OF
WAREHOUSES USED FOR STORING OF TEA - 2026

In accordance with the Sri Lanka Tea Board (Warehousing of Tea) Regulations 1984 published in Government Extraordinary Gazette No. 326/17 of 05th December, 1984 as amended by Government Extraordinary Gazette No. 418/11 of 10th September, 1986 and as further amended by the Government Extraordinary Gazette No. 1280/8 of 20th March, 2003 all warehouses used for storage of tea 1000 kgs. or above at any time, should be registered with Sri Lanka Tea Board. All registration of warehouses under these Regulations should be renewed annually on or before the 31st December.

- Application forms for registration or renewal of registration of Warehouses for the year 2026 under these
 Regulations and any further details can be obtained from the Deputy Tea Commissioner (Exports)
 (Tel- 011-2504090) Sri Lanka Tea Board or could be downloaded from the Sri Lanka Tea Board official website
 (www.srilankateaboard.lk)
- Duly completed applications for the year 2026 should be forwarded to Deputy Tea Commissioner (Exports),
 Sri Lanka Tea Board, Tea Exports Division, 574, Galle Road, Colombo 03 on or before 30th November, 2025.
- 4. In the aforesaid Regulations "Warehouse" means any building used for the purpose of storing tea by Brokers, Manufacturers, Processors, Transporters, Forwarders, Sellers and Buyers excluding factories registered for the manufacture of tea under the Tea Control Act. No.51 of 1957.
- Every person who contravenes or fails to comply with any provision of these regulations or furnishes false information or returns to Sri Lanka Tea Board shall be guilty of an offence, punishable in terms of these Regulations.
- The registration fee for new registration is Rs. 25,000/- + 18% VAT (Total fee is Rs. 29,500/-). Every warehouse above renewal annually on or before 31st December for the following year. The renewal fee is Rs. 10,000/- + 18% (VAT Total fee is Rs. 11,800/-.)
- Payment of registration fee or renewal fee could be made either in cash or cheque. All cheques should be drawn in favour of "Sri Lanka Tea Board".
