**FINANCIAL ASSISTANCE FOR GREEN TEA LEAF CRATES AND STANDARD NYLON BAGS FOR GREEN LEAF DEALERS AND TEA FACTORIES - 2026**

**1. Introduction :**

- (i) The Sri Lanka Tea Board has decided to assist in purchasing Green Tea leaf crates and Standard Nylon bags for Green Tea leaf dealers and Tea factories with a view to minimize post-harvest damage during the transportation of Green Tea Leaves. A maximum of Rs. 2500 is granted for a specified Green Tea Leaf transporting Crate and a maximum of Rs. 400 is granted for a specified Standard Nylon Bag.
- (ii) Registered Tea Factory owners and Licensed Green Tea Leaf Dealers are eligible to receive subsidy for maximum of 100 plastic crates and 200 Standard Nylon Bags.

**2. Method of application:**

- (i) Application for obtaining of Plastic crates and Standard Nylon bags under this scheme should be made available in the prescribed application form No.TC/Productivity/383/2026.
- (ii) It is compulsory to provide all the information as required by the application form. Failure to furnish the required information will lead to rejection of the application. Duly completed applications should be submitted to the relevant Assistant Tea Commissioner of the area where the factories are located on or before 31<sup>st</sup> January 2026. As the funds are limited, the applications will be entertained on a "First come first Serve" basis.
- (iii) Only the registered tea manufacturers and the registered green leaf dealers or persons authorized by them in writing are authorized to sign the application. (The letter should be attached)

**3.0 Methods for purchasing Green Tea Leaf crates and Standard Nylon bags:**

Once the application is received by the relevant SLTB office in the area, arrangements will be made to conduct the necessary inspections to verify the information in the application. After ratification by the officers of the SLTB, the application will be forwarded to the Tea Commissioner, who is the approving authority. Once the application is approved, the applicant will be informed of the specifications and guidelines to purchase plastic crates and Standard nylon bags. The relevant subsidy amount will be granted for the successful purchase upon the submission of the proofs of purchase. The Subsidy payment will directly be made to the bank account number of beneficiary. The beneficiary should provide the payment details with the application.

**4.0 Applicants are required to furnish true and accurate information and need to assist inspectors at the time of field inspection and whenever they are required additional information regarding the applications.**

Providing false or information known to be false is a punishable offense under section 41 of the Tea Control Act No. 51 of 1957 as amended. Apart from being liable to furnish under the aforesaid act, providing false information will immediately disqualify the company from current and any future subsidy schemes and will be liable to refund any subsidies already paid. Such companies may also become liable to be punished under the penal code for the embezzlement of state funds.
