**SUBSIDY ASSISTANCE TO ASSESS AND TRAIN TEA FACTORY OFFICERS IN  
COLLABORATION WITH NATIONAL INSTITUTE OF PLANTATION MANAGEMENT &  
VOCATIONAL TRAINING CENTER - 2026**

**1. Introduction:**

The presence of skilled and well-trained factory officers in the tea factories are of utmost importance to manufacture made tea with good quality. The factory officers should be equipped with the abilities to maintain the Good Manufacturing Practices in order to uphold quality parameters of made tea leading to a higher selling price.

Having considered the above, Sri Lanka Tea Board has initiated a programme to assess and train factory officers attached to tea factories in order to bring them to a level of equal knowledge and capacity.

Budgetary provision is available to be utilized for the above programme for the year 2026 and NVQ level IV certificate will be awarded to successful candidates.

**2. Method of Application**

- a) Any factory officer who is attached to a tea factory with a working experience more than 01 year and 06 months is eligible to apply for this programs.
- b) Duly completed application (Application for the National Vocational Qualification Certificate NVQ - RPL) should be submitted to the relevant Assistant Tea Commissioner of the area on or before **15<sup>th</sup> February 2026**.
- c) Application should be accompanied with the letter of Registered Tea Manufacturer indicating the applicant's employment status with the period of service and the copy of NIC / Driving License.

**3. Procedure of Training Program**

- a) Applications are entertained on **First come First Serve Basis**.
- b) Training sessions are organized by Sri Lanka Tea Board with the assistance of NIPM and Vocational training Center.
- c) This program consists an Initial Assessment and a Final Assessment.
- d) Applicants who are successful in the final assessment are eligible to receive NVQ Level IV certificate.
- e) Applicants who are not successful in the final assessment will be directed to a three days residential knowledge gap filling programme.

**4. Three days residential knowledge gap filling program**

This programme has been designed to address competency gaps, ensuring participants to attain the required knowledge and skills to meet industrial standards.

**5. Terms and Conditions of the scheme**

- a) Assessment fee (Approximately Rs 13,800/- per person) will be paid by the Sri Lanka Tea Board.
- b) Cost of knowledge gap filling program (Approximately Rs 27,500/-per person) should be paid by respective Registered Tea Manufacturer.
- c) Assessment will be conducted by a team of expert of Vocational training center.
- d) Residential Knowledge gap filling programme will be conducted by the NIPM.
